Child maltreatment is abuse to children under 18 years of age by a parent, caregiver, or another person in a custodial role (e.g., clergy, coach, teacher).

Neglect is the failure to provide for the development of the child in all areas relating to the child's well-being: health, education, emotional development, nutrition, shelter and safe living conditions. This failure to provide causes, or has a high probability of causing harm to the child health or physical, mental, spiritual, moral or social development. This includes the failure to properly supervise and protect children from harm as much as is possible.

The reporting and investigation of child maltreatment, and the response to it, involve people from many different walks of life, ranging from parents, relatives, and acquaintances to child-care workers, teachers, association members, volunteers in children's aid societies, Child Protection Offices, police officers, prosecutors, and judges.
